RESOLUTION OF THE SANGGUNIANG BAYAN OF CAVINTI, LAGUNA REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) A 50 HECTARES PARCEL OF LAND FROM THE COMMUNAL FOREST AREA LOCATED NEAR THE CAVINTI UNDERGROUND RIVER AND CAVE COMPLEX IN CAVINTI, LAGUNA TO BE USED AS THE TOURISM OFFICE.

WHEREAS, the Local Government of Cavinti, Laguna aims to promote our Tourism Industry and as the main component of local economic growth of this municipality;

WHEREAS, tourism revenue will be a big contributory factor for our local government unit to financed development projects and initiaves for the benefit and welfare of its constituents;

WHEREAS, the Municipality of Cavinti, Laguna is blessed to have a huge timberland area that helps in ecological balance;

WHEREAS, LGU-Cavinti Tourism, MPDC and Municipal Assessor were able to identify a portion of land commonly known as the communal forest of the Department of Environment and Natural Resources (DENR) within the jurisdiction of Cavinti, Laguna measuring more or less 50 hectares of land within the kilometer radius of the famous Cavinti Underground River and Cave Complex and that will also serve as the protected area for the said cave;

to allot and grant a communal forest area within the radius of Cavinti Underground River and Cave Complex with a measurement of at least Fifty (50) hectares more or less;

WHEREAS, the said communal forest once granted, shall serve as an eco-tourism park intended to promote Cavinti on its various crops and provide oither alternative methods for the local revenue generation;

WHEREFORE, in view of the foregoing, on motion of SB Member Charles Clifford F. Matta, and by unanimous consent of all the members, there being a quorum, it was

RESOLVED, as it is hereby RESOLVED, to REQUEST the Department of Environment and Natural Resources (DENR) to provide the Local Government Unit of Cavinti, Laguna a parcel of land measuring 50 hectares from the communal forest located within kilometer radius to our famous Cavinti Underground River and Cave Complex, in Cavinti, Laguna and that will serve as the protected area for the said cave.
