**WHEREAS**, Cavinti as a town has an abundant water sources such as the Lumot Lake but does not have enough facility to provide water especially for bathing and laundry;

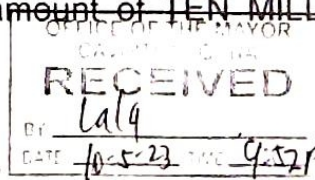
