WHEREAS, pursuant to the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991 and its implementing rules and regulations, the Sanggunian Bodies have the inherent right and obligation to adopt its own Rules of Procedure for the proper discharge of legislative functions in order to achieve efficient and effective governance;

WHEREAS, in the maintenance of good order in the legislative processes, it is necessary that specific rules be adopted and enforced in the interest of effective discharge of legislative functions;

WHEREAS, Section 15 of amended rules of the Internal Rules and Procedures of the Sangguniang Bayan of Cavinti Laguna, provides that the Regular Session of the Sangguniang Bayan will be held in the Barangay every Second and Fourth Session day of every month;

WHEREAS, the Sangguniang Barangay are now starting to prepare for the upcoming Barangay Election that will be held on October 30, 2023;

WHEREAS, the Sangguniang Bayan is currently headed by the SB Charles Clifford F. Matta, as the Acting Vice Mayor and Presiding Officer that Matta, as the Acting vice iviayor and resolution of the Chairmanship, Vice OFFICE OF THE MAYOR CAVINTI, LAGUNA resulted in the Chairmanship and Membership in all committees;

WHEREAS, membership of the Acting Vice Mayor and Presiding Officer in the MANDATORY and OTHER STANDING COMMITTEES shall also be temporarily renounced but need not require replacement;

WHEREAS, the functions provided in each affected Mandatory and Other Standing Committees shall not be affected by the temporary replacements of its membership;

NOW THEREFORE, in view of the foregoing, on motion of SB Member Romel J. Villanueva and unanimously seconded and approved by all other SB Members herein present, there having a quorum

RESOLVED, as it HEREBY RESOLVED TO CREATE INTERIM AMENDMENTS OF SECTIONS 15, 95 AND 96 THE INTERNAL RULES AND REGULATIONS OF THE SANGGUNIANG BAYAN OF CAVINTI, LAGUNA, as follows:

Section 15. Unless specified or scheduled otherwise, the Regular Session of the Sanggunian shall be held every Monday, 9:00 AM at the Sangguniang Bayan Session Hall;

The Sessions to be held in the Sangguniang Barangay Session Hall will be temporarily suspended after the 58th Session and to resume on January 2023, unless re-scheduled or extended otherwise by the members of the Sangguniang Bayan;

If any of the regular session falls on a non-working holiday, the session shall be conducted on the next working day or scheduled in a different date concurred by majority of the Sanggunian.
