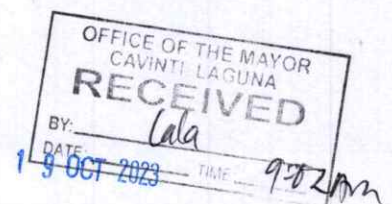
WHEREAS, endorsing this feasibility study is a significant step toward fostering a cleaner and greener future for our community in Cavinti, Province of Laguna;

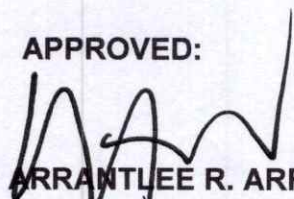
