MUNICIPAL ORDINANCE NO. 054 - 2025

AN ORDINANCE PROHIBITING GAMBLING AND ILLEGAL GAMING IN THE MUNICIPALITY OF CAVINTI, LAGUNA, AND IMPOSING PENALTIES FOR OTHER PURPOSES.

WHEREAS, after careful review and due deliberation, the committee finds that the said Municipal Ordinance will be a great help to Municipality of Cavinti to avoid illegal gambling;

WHEREAS, the Municipality of Cavinti, Laguna, recognizes the need to protect its citizens from the adverse effects of illegal gambling activities, and must enact measures that promote peace, order, and good governance;

WHEREAS, under Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the local government of Cavinti, Laguna is expressly vested with police power, to promote the general welfare, improve public morals, maintain peace and order, and preserve the comfort and convenience of its inhabitants;

WHEREAS, Article Three, under Section 447. Powers, Duties, Functions, and Compensation (a) The Sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions, and appropriate funds for the general welfare of the municipality and its inhabitants par (1) (iii) Approve imposing a fine not exceeding Two Thousand Five Hundred Pesos (₱2,500.00) or an imprisonment for the period not exceeding six (6) months, or both in the discretion of the court, for the violation of a municipal ordinance;

WHEREAS, under the same section par (v) the Sangguniang Bayan is authorized to enact ordinances intended to prevent, suppress and impose appropriate penalties for gambling and other prohibited games of chance, fraudulent devices and ways to obtain money or property, and other such activities inimical to the welfare and morals of the inhabitants of the municipality;

NOW, **THEREFORE**, be it **ORDAINED** by the Sangguniang Bayan of Cavinti, Laguna in session assembled that:

SECTION 1.

TITTLE. This ordinance shall be known as the "ANTI GAMBLING AND ILLEGAL GAMING Ordinance of Cavinti, Laguna".

SECTION 2.

PURPOSE. The purpose of this ordinance is to prohibit gambling and illegal gaming from proliferating in the Municipality of Cavinti, Laguna as these acts are inimical to the welfare or morals of the people of the community and greatly influence the individuals to disregard the value of dignified work, perseverance, and thrift. This ordinance is enacted to comply with the provisions of Republic Act No. 9287 amending Presidential Decree No. 1602, Executive Order No. 13, and all other pertinent rules and regulations regarding illegal gambling and illegal gaming under different Memorandum Orders of concerned national government agencies.

SECTION 3. DEFINITION OF TERMS.

- Bingo a game in which players mark off numbers on cards as the numbers are drawn randomly by a caller on a pre-printed 5 by 5 matrix card, which may be printed on paper or card stock, or electronically represented.
- Card games refers to the games that involve the use of playing cards or "baraha" such as but not limited to blackjack, lucky nine, pusoy, pusoy dos, tong-its, bet game/poker, and the like.
- Cara y Cruz refers to coin flipping, coin tossing, or heads or tails is the practice of throwing a coin in the air and checking which side is showing when it lands, to randomly choose between two alternatives, heads or tails, sometimes used to resolve a dispute between two parties.

- Color Games refers to a set of color dice, typically in red, yellow, green, blue, pink, and white players place their bets on one or more colors.
- Ending refers to the two (2) digit combination when the basketball games end, both teams will have their final score to determine the winning numbers.
- Mahjong a Chinese game played, usually by four people, with 136 or 144 rectangular pieces called tiles. The object is to collect winning sets of these tiles, as in card games such as gin rummy.
- Motor Racing refers to street racing competitions and related activities involving modified motorcycle racing on a public road in an illegal form.
- Sabong refers to a blood sport involving roosters, held in a ring called a cockpit or tupada.
- 9. Spider Fighting refers to spider derby involving money as a bet.

SECTION 4.

GENERAL PROHIBITION ON GAMING. It shall be unlawful for any person to participate directly or indirectly in any scheme or activity that involves placing money or any article of value as bets and where winning depends on luck skill or both.

SECTION 5.

PROHIBITED ACTS. The following acts of gambling or illegal are prohibited: bingo, cara y Cruz, card games, color games, mahjong, sabong or tupada, motor racing, basketball and volleyball bets or any other game or scheme, whether upon chance or skills, which do not have a franchise from the national government, wherein consisting of money or articles of value are made.

SECTION 6.

EXEMPTIONS. The following are exempted from this ordinance:

- a. Conduct or holding of "BINGO SOCIALS". "POPULARITY CONTEST", or "RAFFLES" and similar fundraising activities are exempted from the provisions of this ordinance, provided, that a permit thereof has been secured "certification of exemption" from the Municipal Mayor and when said activities shall be undertaken within the territorial jurisdiction of the concerned barangay, and/or the Barangay Captain should request to the Local Chief Executive for issuance of exemption, and Cavinti Police Station should copy furnished.
- Card games, bingo, and mahjong as compassionate justice during the "wake or to hold a vigil for someone who died".

- c. Isolated incidents such as during family gatherings and occasions or during drinking sessions, provided that such is not done for profit and is not regularly held but is solely incidental to such gathering or drinking session;
- d. Perya is allowed during the Town and Barangay Feast day but they need to secure regulatory permit from the Sangguniang Barangay and the Office of the Mayor;

SECTION 7. RULES AND REGULATIONS:

- a. No person shall allow any form of gambling mentioned and embraced in the preceding section to be conducted or carried on in any real property that he owns or under his administration and control.
- No person shall participate, directly or indirectly, in any gambling referred to in Section 1 thereof.
- c. No person shall possess any ticket, paper, or matter containing letters, figures, signs, or symbols that pertain to or are connected with the game of "ending", or similar games prohibited herein, nor possess cards, and other gambling paraphernalia, which have been used or about to be used, in any illegal gambling mentioned herein. Mere possession of those things before, during, and immediately after the conduct of such illegal gambling shall be considered as "prima facie" evidence for this ordinance.

SECTION 8.

PENALTY. Any person who violates any provision of this ordinance shall be punished by the following:

1st Offence - ₱ 1.000.00

2nd Offence - ₱ 2,000.00

3rd Offence - ₱ 2,500.00

SECTION 9.

MINOR OR CHILD OFFENDERS. Refers to a person under the age of eighteen (18) years, shall be dealt with in accordance with Juvenile Justice and Welfare Act [R.A. No. 9344, as amended by R.A. No. 10630] "AN ACT ESTABLISHING A COMPREHENSIVE JUVENILE JUSTICE AND WELFARE SYSTEM, CREATING THE JUVENILE JUSTICE AND WELFARE COUNCIL UNDER THE DEPARTMENT OF JUSTICE, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES".

SECTION 10.

CITATION TICKET - The Municipal Treasurer's Office thru authorize person responsible shall issue citation ticket/s within 24 hours.


