WHEREAS, Section 43 of R.A 6975 prescribes that there shall be created by the Sangguniang Panglunsod/ bayan in every Municipality and City a People's Law Enforcement Board;

WHEREAS, the same Section of R.A 6975 provides that the People's Law Enforcement Board (PLEB) shall be composed of : (a) Any member of the Sangguniang Panglunsod/Bayan chosen by his respective Sanggunian;

WHEREAS, the People's Law Enforcement Board (PLEB) shall have jurisdiction to hear and decide citizen's complaints or cases filed before it against erring officers and members of the PNP,

WHEREAS, the Sangguniang Bayan of Cavinti unanimously chosen HON. ROMEL J. VILLANUEVA SB Member, this municipality as representative of the Sangguniang Bayan to the People's Law Enforcement Board;

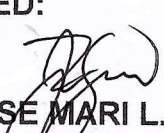
