pressure apparatus, stethoscopes, pulse oximeters, thermometers, and medical
bags is crucial in equipping BHWs with the proper instruments to effectively carry
out their duties in monitoring, recording, and addressing the primary health needs
of the residents;

WHEREAS, there are one hundred (100) active BHWs across the
barangays of Cavinti who require updated and standardized medical kits to
ensure the delivery of reliable, efficient, and consistent health services;

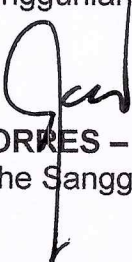

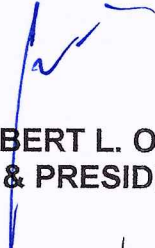
