

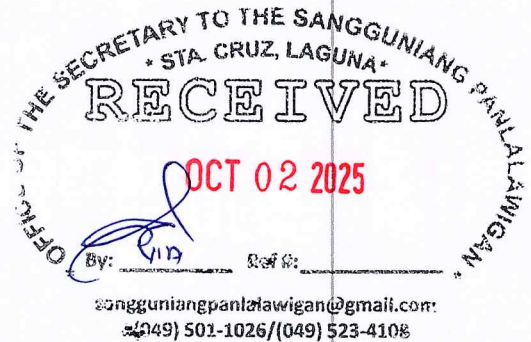

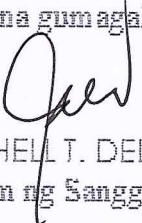

MUNICIPAL ORDINANCE NO. 049 – 2025

AN ORDINANCE RECOGNIZING SEPTEMBER 12, 1907 AS RECONSTITUTION DATE OF THE MUNICIPALITY OF CAVINTI AND DECLARING SEPTEMBER 12 OF EVERY YEAR AS RE-ESTABLISHED MUNICIPAL ANNIVERSARY OF THE TOWN OF CAVINTI AND OTHER PURPOSES.

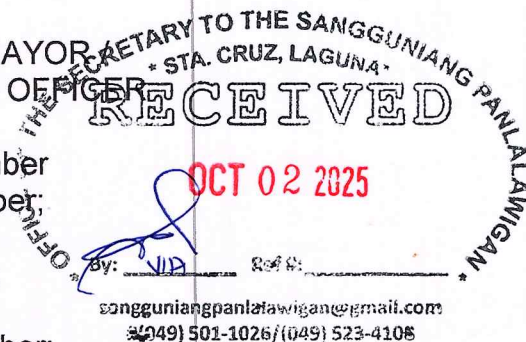
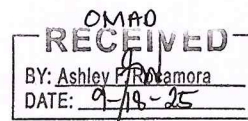

WHEREAS, during the Spanish Period, the Municipality of Cavinti was a part of Lumban [Laguna] and believed that by the virtue of the Papal Bull directly from Rome, the town gained complete independence in the year 1619;

WHEREAS, the American Governorship during the American Occupation of the Philippines passed Act No. 939, dated October 12, 1903 otherwise known as "An Act Reducing the Thirty Municipalities of the Province of La Laguna to Nineteen (19)";

WHEREAS, Act No. 939 stated that, "the Municipality of Luisiana shall consist of its present territory and that of the Municipality of Cavinti, with seat of the Municipal Government at the present Municipality of Luisiana;

WHEREAS, the Philippine Commission on 1907 enacted Act No. 1712 dated September 12, 1907 entitled "AN ACT TO INCREASE THE NUMBER OF MUNICIPALITIES IN THE PROVINCE OF LA LAGUNA FROM TWENTY-TWO

TO TWENTY THREE, BY SEPARATING FROM LUISIANA THE FORMER MUNICIPALITY OF CAVINTI AND GIVING TO IT THE TERRITORY WHICH IT COMPRISED PRIOR TO THE PASSAGE OF ACT NUMBERED NINE HUNDRED AND THIRTY-NINE.;

WHEREAS, on the year 2019 marked the 400th anniversary of the town of Cavinti, Province of Laguna as an independent Pueblo and on the year 2007 as 100th year of the reconstitution and re-established Municipality after separating from the town of Luisiana;

WHEREAS, the identification of the Reconstitution Day or the Foundation day is an important undertaking in the enrichment of ones cultural and historical heritage;

WHEREAS, the passage of this ordinance will not only regenerate but will also strengthen the Cavintiin preservation of their rich cultural heritage and keep the passion and love burning which is one relevant factor in solidifying a community;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan in its Regular Session assembled that,

SECTION I. SHORT TITLE - This ordinance shall be known as
"THE SECOND FOUNDING ANNIVERSARY OF CAVINTI"

SECTION II. COVERAGE. This Ordinance is to declare that September 12 of every year as The Reconstitution Date and Second Founding Anniversary and cover all the territory of the Municipality of Cavinti.

SECTION III. PARTICIPANTS /MEMBERS OF THE RE-CONSTITUTION DAY.

- Municipal Officials and Employees;
- Dep Ed Cavinti Sub-Office particularly the CPSTA;
- Some Group of Students both Public and Private;
- Barangay Officials;
- Heritage Advocates;
- NGO'S.

SECTION IV. ACTIVITIES DURING THE RECONSTITUTION DAY.
There shall be an Official One (1) day celebration during the Second Founding Anniversary of the Municipality with relevant activities not limited to the following:

- Thanksgiving Mass;
- Nationalistic Parade;
- Flag Raising and Tribute to the Flag;
- Messages of the Municipal Mayor and other Municipal Officials;
- Inspirational and Patriotic Speech from Students;
- Flower Offerings to Heroes Shrine;
- Folk Dancing;
- Playing Folk Instrument;
- Playing Native Game;
- Slogan Making about Cavinti's History;
- Poster Making; and

SECTION V. CREATION AND COMPOSITION OF THE COMMITTEE.

The committee shall be created and composed of the following persons and/or Municipal Officials;

Chairperson	-CHATTO Officer;
Vice Chairperson	-Municipal Administrator;
Members	-Sangguniang Bayan Member/s -Chairperson of Committees Education, Tourism Culture, and Arts or equivalent committee -Sangguniang Kabataan Federation President; -Cavinti Sub-Office District Supervisor; -Heritage and Cultural Advocates President; -Liga ng mga Barangay President.; -CAMEA President. -President, CTSOA

The members of the Committee are hereby directed to name their respective representative/permanent, alternate representatives who shall take their place in case of their absence.

SECTION VI. FUNCTIONS. The Committee shall perform the following functions;

- Plan and ensure the smooth coordination of programs, events, and activities in connection with the celebration;
- Find ways and means to support the effective implementation of programs, events and activities during the celebration;
- Set guidelines, authorize and/or approved the utilization and accounting of funds for the event;
- Perform such other acts that are necessary to effectively and meaningfully carry out their mandated functions;

SECTION VII. SPECIAL PROVISION. The Office of the Mayor shall submit the request for the issuance of the Presidential Proclamations thru the Sanggunian Bayan Resolution declaring special non-working holiday after the enactment of this ordinance or not less than thirty (30) days before September 12, the declared Reconstitution Date, to the Office of the President through the Office of the Executive Secretary;

SECTION VIII. FUNDING. For the effective implementation of this ordinance, the Municipal Government of Cavinti, shall appropriate the amount One Hundred Thousand Pesos (Php100,000.00) included in the annual budget as an initial fund and may be subject to augmentation as the need arise, subject to the availability of funds for the success of the celebration.

SECTION IX. SEPARABILITY CLAUSE. If any provision or part thereof is held invalid or unconstitutional, the provision not otherwise affected shall remain valid and subsisting.

SECTION X. REPEALING CLAUSE. Any law, presidential decree or issuance, executive order, rules or regulations contrary to, or inconsistent with the provisions of this Ordinance is hereby repealed, modified or amended accordingly.

SECTION XI. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon approval and posted in Website/Social Media Account of the Municipality and other conspicuous places within the municipality.

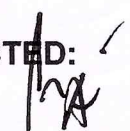

Binuksan ni SB Glenn Haze M. Cabuhat ang Pampublikong Pagdinig sa ganap na ika-9:40 ng umaga. Sinundan ng isang panalangin na pinamunuan ni SKF Limron O. Sanchez.

Sa pagpapatuloy ni SB Glenn Haze Cabuhat ay kinilala niya ang lahat-lahat ng nagsidalo sa patawag na ito. Sinabi ng kagawad na ang inanyayahan ay ang mga Barangay Kagawad na may hawak ng *Committee on Tourism* at ang mga SK ng 19 na barangay.

Tinungkulan ang sipi ng nasabing panukala at binasa ni SB Glenn Haze M. Cabuhat ang nilalaman nito. Matapos itong basahin, sinabi niya na ang *celebration* ng *August 6 ay holiday* na dito at aniya'y sapagkat si SB Romel J. Villanueva ay mahilig maglalugad, kaya't nag-akda ng isang panukala upang ang *September 12* ay gawing *holiday* dito sa Cavinti. Kaya para hingin ang opinyon/suhestyon ng bawat isa kaugnay sa paksa ay ibinukas ni Glenn Haze M. Cabuhat ang hapag upang marinig ang kanilang panig.

Sang-ayon kay SB Romel J. Villanueva bilang isang namumuno sa bayan at ang paggawa ng ordinansa ay bahagi na rin ng tungkulin, aniya'y tulad din ng mga nanunungkulan sa barangay na gumagawa rin ng ganito upang makapag-ambag ng kaalaman. Kaya ayon sa kagawad ay nag-akda siya ng ordinansa na tumutukoy sa pagpapahalaga at pagyamanin ang kultura ng ating bayan. Dagdag pa niya na ang ordinansang ito ay kahalintulad din ng pagpapangalan ng mga kalye, gaya sa Udia, aniya'y dapat ay bukas ang isipan ng mga opisyal kung paano pagyayamanin ang kultura doon. Ipinaliwanag din ni SB Romel J. Villanueva kung paano niya binuo ang ordinansa at ipinakita niya ito sa pamamagitan ng *Wikipedia* ng Cavinti, gamit ang *wide screen*. Dito ay binanggit din ng kagawad na ang Cavinti noon ay isinama sa Luisiana noong mga panahon ng Amerikano at base sa *Act No. 939, dated October 12, 1903, na may pamagat na "An Act Reducing Thirty (30) Municipalities of the Province of La Laguna to Nineteen (19)".* Sinabi pa ni SB Romel J. Villanueva na sa katagalan noong Setyembre 12 ay nagbatas ang *American Governorship* ng *"An Act No. 1712 dated September 12, 1907 na may pamagat na "An Act to increase the number of municipalities in the province of Laguna La Laguna from twenty Three, by separating from Luisiana the former municipality of Cavinti to its territory which is comprised prior to the passage of Act Numbered Ninety Hundred and Thirty Nine."* Sinabi ng kagawad na sa mga panahong ito inihiwalay na ang bayan ng Cavinti sa Luisiana. Nabanggit din ng kagawad na sa Luisiana ay mayroon *historical marker* na doon ay nakalagay ang mga ninuno natin na namuno sa bayan, tulad nina Tomas Pereja at Pedro Pereja. Sinabi pa ng kagawad na ang ordinansang ito ay pweding pag-ugatan ng iba-ibang programa kapag ang *September 12* ay naideklara na *reconstitution date* ng ating bayan. Ipinapalarang din niya na noong nakaraang Hulyo bago magpista kung kailan ay nag sumite si SB Romel J. Villanueva ng *request letter* sa Pangulo Bombong Marcos na ang *August 6* ay madeklara bilang mahalagang araw ng bayan ng Cavinti sapagkat ang bawat bayan naman ay mayroong kinikilalang mahalagang araw/kapistahan.

Bilang kapunahan ni SKF Limron O. Sanchez sa pamagat ng ordinansa, kung saan ay isinuhestyon sa hapag na dapat ang isaad rito ay *re-established* at hindi *"SECOND FOUNDING ANNIVERSARY"* sapagkat opinyon ni SK na mas akop gamitin ang *"RE-ESTABLISHED"*. Kaya ganito ang magiging pamagat ng ordinansa: **AN ORDINANCE RECOGNIZING SEPTEMBER 12, 1907 AS RECONSTITUTION DATE OF THE MUNICIPALITY OF CAVINTI AND DECLARING SEPTEMBER 12 OF EVERY YEAR AS RE-ESTABLISHED OF THE MUNICIPALITY OF CAVINTI AND OTHER PURPOSES."**

Paglililaw ni Barangay Kagawad Joel Garcia ng Poblacion at itinanong kung ano ba ang mga programang dapat isagawa sa selebrasyon ng Setyembre 12 na pagkakatatag ng Bayan ng Cavinti? Aniya'y dapat ay may ganito, kaya isinuhestyon niya na kailanga'y magkaroon ng aktibidades sa tuwing sasapit ang petsang ito para matatak sa mga tao ang kahalagahan ng araw na ito.

Sang-ayon kay SB Romel J. Villanueva ay ang tanggapan ng Punong Ehekutibo ang bahalang maglagay kung ano ang mga nararapat na programang gagawin bilang doon ang implementasyon ng batas. Dagdag pa ng kagawad na kapag ang ordinansa ay mapagtitibay, ito ang pag-uugatan kung ano ang mga ilalapat na aktibidades. Opinyon pa niya na pwede na rin namang maglagay na ng seksyon ukol rito, *like flower offering, slogan contest etc.* Ito ay matatala sa ordinansa, gaya ng sumusunod: "SECTION IV. ACTIVITIES DURING THE DAY.

Kaugnay sa *activities*, sinabi ni SB Glenn Haze Cabuhat na noong nakaraang pagpupulong kung kailan ay napag-usapan ang ordinansa sa *reconstitution date*, isa sa naging bahagi ng talakayan ay ang ilalapat na programa. Kaya aniya ay nararapat na magkaroon ng mga programa kapag Setyembre 12.

Bilang karagdagang impormasyon, ipinararating ni SKF Limron O. Sanchez na sa bayan ng Luisiana ay magkabukod ang pagsi-celebrate ng piyesta at ng *Pandan Festival* at may magkakaibang programang ginagawa dito. Samantalang dito sa Cavinti ay magkasabay na ang pista at Sambalilo Festival.

Pabor din si Barangay Kagawad Eufemia Trinidad ng Kanluran Talaongan na magkaroon ng mga iba-ibang *activities*, halimbawa nga nito ay *singing contest, slogan making contest/ Rondalla music*. Ito ay magsisilbing isang magandang ehemplo para ipakita ang sinaunang kultura at magiging makabuluhan din ang selebrasyon. Dagdag pa niya na ang tema ng *slogan* ay ibabase sa pagkilala sa araw ng Setyembre 12 at ang mga programa ay pangmaghapunan lamang. Suhestyon din niya magkakaroon ng iba-ibang komite na mamamahala sa okasyon.

Karagdagang suhestyon ni Barangay Kagawad Joel Garcia na dapat ang mga ihahandang palaro ay iyong mga larong Cavitiin bilang pagbabalik tanaw sa ating kasaysayan.

Sa pagtatapos ni SB Romel J. Villanueva, opinyon at suhestyon din niya na ang mga Barangay Kagawad na humahawak ng *Committee on Education* ay maaari ring bumuo ng tulad ng ganitong ordinansa sa kanilang barangay na nasasakupan. Dahil mahalaga na ang isang barangay ay mag-celebrate/maipakita ang ng kanilang natatanging araw.

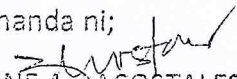
