

DTTB physician to Cavinti which will significantly contribute to ensuring the continuity of health programs and the attainment of better health outcomes for our constituents;

WHEREAS, the Municipality of Cavinti in the Province of Laguna, Region IV-A (CALABARZON), is a rural locality that continues to face challenges in providing consistent and adequate healthcare services due to the shortage of medical professionals and limited access to government health programs;

WHEREAS, at present, Cavinti's local health system is served by one (1) doctor, two (2) nurses, six (6) midwives, one (1) Rural Health Unit (RHU), and ten (10) Barangay Health Stations (BHS) which the current manpower remains insufficient to fully address the growing and diverse health needs of the population and needs of the 19 Barangays in Cavinti, particularly in the Unserved and Underserved Areas (UUAs).

WHEREAS, the inclusion of Cavinti in the DTTB program would significantly benefit its constituents by ensuring the presence of competent physicians to strengthen its local health system, deliver essential services, and enhance the municipality's capacity to respond to medical and public health concerns;

WHEREAS, the Municipal Government of Cavinti expresses its full support and commitment to collaborate with the Department of Health in providing the necessary logistical and institutional support to any physician assigned through the DTTB program;

WHEREAS, there is an urgent need to bridge the healthcare service gap in rural municipalities such as Cavinti to achieve equitable health outcomes and improve the quality of life of its residents;

NOW THEREFORE, given the foregoing deliberation on the matter, upon motion of SB Glenn Haze M. Cabuhat, and by unanimous consent of all other SB Members herein present, there being a quorum, it was
